The meeting was called to order at 5:30 p.m. by Mr. Bramlett.

Dr. Downs recommended approval for the Work Session agenda with minor changes. Dr. Downs spoke to the Board about the current guidelines regarding COVID-19 and large gatherings. With the guidelines in place there will be no presentations and recognitions at this time. Motion by Mr. Ocobock and second by Mr. Watkins to approve the Work Session agenda. Motion Carried. All voted Yes.

Superintendent's Report:

1. **Academic Achievement:** Dr. Downs noted that Mountain View Elementary was scheduled to have students give a presentation. That presentation has been tentatively rescheduled for the Work Session on April 13, 2020.

- 2. **Parent and Community Engagement:** 2020-2021 Academic Calendars: Dr. Downs explained that an email was sent to parents, students and staff of the Gilmer County School System with a link to the 2020-2021 calendar survey. Each link could only be used once and a spreadsheet was created to verify that each email was only able to vote once. The district received 1,538 responses to the survey. Calendar #1 which is almost identical to Cherokee County and similar to Cobb and Paulding Counties was preferred and received 60% of the votes. Calendar #2 which is similar to recent Gilmer calendars received 28.74% of the votes. Calendar #3 which is similar to Fannin County received only 10.66% of the votes. Dr. Downs add that based on the response from the districts stakeholders a recommendation to approve Calendar #1 for the 2020-2021 School Year will be made at the Regular Session on Thursday March 19, 2020.
- 3. **High Performing Culture and Workforce**: Personnel: Dr. Downs noted that personnel will be discussed further in Executive Session.

4. **Operational Effectiveness:**

- a. Compliance/Policy (First Reading): The following policies were presented for first reading in order to comply with recent changes in the law and/or GSBA recommendations to update the current wording:

Subject to feedback and public deliberations, these will be voted upon at the Regular Session on April 16, 2020.

The district has received feedback from administration and from legal counsel. Dr. Downs noted that policies are set for approval at the Regular Session March 19, 2020.
