Superintendent's Report:

1. Academic Achievement:

a. Gilmer High School: Principal Ms. Carla Foley introduced Gilmer High's Career, Technical and Agricultural Education (CTAE) teachers to the Board. Each CTAE teacher presented to the Board about their pathway, the requirements within the program and the students' hands own activities and experiences.

2. Parent and Community Engagement:

a. Reapportionment: Dr. Ridley stated that the district was contacted by the states Reapportionment office regarding the re-balancing of the Board districts. Dr. Ridley referred to the proposed map provided in the Board folders. The original map that were revised in 2012 show the existing Board district lines. New Board district lines were proposed to accommodate growth within the county and within the districts. Dr. Ridley noted that a recommendation for approval of the proposed map will be made at the Regular Session on Thursday January 27, 2022.

3. High Performing Culture and Workforce:

- a. Personnel: Dr. Ridley noted that personnel will be discussed in Executive Session.
- b. Administrative Renewal: Dr. Ridley noted that the administrative renewals are for the 2022-2023 school year and include district office directors along with principals. A recommendation for approval for administrative renewal will be made at the Regular Session, Thursday January 27, 2022.

4. **Operational Effectiveness:**

- a. Board and Vice Chair: Dr. Ridley stated that at the Regular Session, Thursday January 27, 2022, the Board will select a Chairman and Vice Chairman for 2022.
- b. Gym Scoreboard Update: Mr. Dana Berry, Assistant Superintendent of Operations updated the Board on the status of the gym scoreboard. The district is expected to receive the load calculation for the ceiling by the end of the week. The tentative timeline for installation will be during the GHSA "Dead Week". Mr. Berry noted that the gym floors will be refinished once the scoreboard is in place.
- c. Compliance/Policy (First Reading): The following policies were presented for first reading in order to comply with recent changes in the law and/or GSBA recommendations to update the current wording:

Dr. Ridley explained that these policies will be posted on the GCSS Website for public review and comment before a second reading at the Board of Education Work Session at next month's meeting. Subject to feedback and public deliberations, these will be voted upon at the Regular Session in January.

- d. Compliance/Policy (Second Reading): Policies presented for first readings in November and have been posted on the GCSS website for public comment and also sent to GSBA for legal counsel review.

The policies have been on the district website since the meeting in December. All policies have been submitted to GSBA legal counsel for review. Changes are as follows: Policy JBCAA – Deadline for School Choice moved from March to June. Policy IDFA – Changes are due to Georgia Equity Sports Act; assess equity opportunities by interest surveys. Policy IFBG – Changes are due to duplication of information contained in the policy. No public input was received. Dr. Ridley noted that a recommendation for approval of these policies will be made at the Regular Session on Thursday January 27, 2022.
