Superintendent's Report:

1. Academic Achievement:

- a. Outdoor Learning Labs: Director of Federal Programs Director and District Title IX Coordinator Ms. Lindy Patterson presented the Board a summary of Federal Grant expenditures for the districts Outdoor Learning Labs.
- b. CCES: Ms. Stephanie Burnette, Principal at Clear Creek Elementary, STEM Lab teacher Ms. Patricia Ellis along with CCES students presented the Board with a with a video of students working together, problem solving and building projects in the lab. Students also got the chance to show off their own STEM lab projects. The Board and Dr. Ridley congratulated students on a job well done.

2. Parent and Community Engagement:

a. Literacy Night – April 29, 2022: Dr. Ridley announced that the districts Family Literacy Night will be held on the field at Huff Mosely Stadium Friday April 29, 2022 from 6pm – 8pm. Each school along with members of the community will have booths set up on the football field with activities and books for children of all ages. Dr. Ridley invited everyone to attend.

3. High Performing Culture and Workforce:

a. Personnel: Dr. Ridley noted that personnel will be discussed in Executive Session.

4. Operational Effectiveness:

- a. Capital Asset Disposition: Dr. Ridley presented the Board with a Capital Asset Disposition form which is used to disposition district items that are no longer needed or in use. Dr. Ridley noted that the form was for informational purposes only and did not require Board approval.
- b. Legion Rd. Fuel Tanks: Dr. Ridley presented the Board with two bids that were received for the fuel tanks located at the transportation barn on Legion Rd. Dr. Ridley explained that the bid received for \$230,371.43 was more detailed due to the parts itemized in the bid. The other

bid received was for \$97,810.00. Dr. Ridley noted that a recommendation for approval of the \$97,810.00 bid will be made at the Regular Session on Thursday April 14, 2022.

- c. Compliance/Policy (First Reading): The following policies were presented for first reading in order to comply with recent changes in the law and/or GSBA recommendations to update the current wording:

 - Policy FGAD Architect Responsibilities in Facilities Projects
 - Policy GCRH Classified Personnel Vacations

Dr. Ridley explained that these policies will be posted on the GCSS Website for public review and comment before a second reading at the Board of Education Work Session at next month's meeting. Subject to feedback and public deliberations, these will be voted upon at the Regular Session in April.

- d. Compliance/Policy (Second Reading): Policies presented for first readings in January and have been posted on the GCSS website for public comment and also sent to GSBA for legal counsel review.

The policies have been on the district website since the meeting in January. All policies have been submitted to GSBA legal counsel for review. Changes received from GSBA legal counsel are as follows: Policy JB Student Attendance to remove the STEP program (Student Teen Election Participant) as part of the attendance policy. No public input was received. Dr. Ridley noted that a recommendation for approval of these policies will be made at the Regular Session on Thursday April 14, 2022.

5. Fiscal Accountability:

- a. Nutrition: School Nutrition Report December 2021: Ms. Patricia Partin, Director of School Nutrition presented the School Nutrition Report December 2021 to the Board.
- b. Athletic Supplements: Dr. Ridley presented the Board with the updated Athletic Supplements for the upcoming school year. A recommendation for approval will be made at the Regular Session on Thursday April 14, 2022.
- c. District Bonus: Dr. Ridley spoke to the Board regarding the \$2,000 bonus approved by Governor Brian Kemp. The state has approved funds the district for 458 of 559 employees which amounts to \$916k. The remaining amount will be paid by the district through CARES Funds. Subs who meet requirements of 10 or more days per month can earn up to \$1000. The bonus total for all employees is \$1,143,690. This amount includes both the state and districts portions. Dr. Ridley noted that a recommendation for approval will be made at the Regular Session on Thursday April 14, 2022.

d. Budget Update:

- i. Purchasing Policy Expenditures and Approvals April 2022: Expenditures and Approvals were presented for informational purposes only and exempt from Board approval.
